What is OLPPP?

- Occupational Lead Poisoning Prevention Program
- Fee-based; created in 1991
- Public health surveillance (tracking)
- Case Management
- Education & outreach

Background

Well-known, historically recognized hazard

One reason for creation of EPA, OSHA

 Environmental lead levels (air, soil) have decreased; lower body burdens in both adults and children

 Currently, no level of lead in blood is considered "acceptable" for children

Background, con't:

- Great progress in reducing children's "BLL of concern"
- "Acceptable" levels of blood lead for adults remain at levels set by OSHA using 30-year old data
- New evidence of harmful health effects at much lower levels than previously thought
- "Elevated" formerly defined as 50 60 ug/dL;
 now, BLLs 5 10 ug/dL considered "elevated"

Health Effects at Lower BLLs:

- Hypertension
- Kidney dysfunction
- Cognitive dysfunction
- Adverse reproductive effects

OLPPP's Action Plan

- Surveillance: Tracking workers with lower BLLs; revising Epi. Case definition(s)
- "Spreading the word" about health concerns at lower levels
- Providing multi-media <u>guidance</u> to employers, workers, health-care providers
- Ultimately, want to see OSHA adopt adequately <u>protective lead standards</u> and lead industries improve practices ~ other policy options?

Taking Action: Surveillance / Epi. Case Definitions

- Revised "Occupational Health Indicators" (now: 10+, was: 25+ and 40+)
- ABLES
- Healthy People 2020
- Nationally Notifiable Condition list

Taking Action: <u>Surveillance</u> / OLPPP Activities

 Contact all workers reported with BLLs 10+ ~ 100/month

Obtain complete information for levels 10+

Present all data at 10+ (not 25+)

Taking Action: Spreading the Word

- Workers: "Workplace Hazard Alert" ~ "New Health Dangers from Lead"
 - Health effects
 - Routes of exposure, "too much"
 - To discuss with MD
 - Workplace prevention activities
 - Lead Standards
